Notes to the Precept Budget

Note 1: Clerk's Salary:

The Clerk is currently paid for five hours per week (260 hours per annum) at point SCP 12 of NALC's pay scale. For the year 2024/2025 she has been paid £13.73 per hour. Retrospectively NALC have issued new pay scales for 2024/2025 increasing the rate to £14.36: the Clerk has therefore been underpaid £163.80 for the 24/25 year, but waives the claim as HMRC grab it all. From 01.04.25 the rate claimed will be £14.36 per hour x 260 hours = £3,733.60. The new NALC rates will be available for inspection at the meeting on 22.01.25.

Note 2: WWI information board funding

 ± 300 was claimed in the 2024/25 Precept – Minute Ref. 235/23. The sum has not yet been spent so has been transferred to a ring-fenced fund whilst awaiting Diocesan approval.

Note 3. 2025 Election costs

SALC have indicated the cost of the 2025 council elections may be £2.30 per elector. DPC has approx. 512 electors = £1178. DPC already has a reserve of £457.73, so will probably need to fund another £720. It was agreed that DPC wait until the 2026/2027 Precept Budget to claim any sums due.
